New AI-Powered Sentencing Tools Developed with Microsoft Support

Since joining Microsoft's startup program, SentencingStats.com has developed a number of breakthrough technologies in the federal sentencing arena. These innovations – built with Azure's AI and cloud services – are already helping public defenders, private lawyers and judges gain deeper insights into sentencing trends:

- **Judge Profiler:** An analytics tool that analyzes a judge's historical sentencing decisions and patterns. It allows attorneys to compare their case to a judge's past cases (by guidelines, offense levels, criminal history, departures and more) and thereby develop more effective sentencing strategies.
- Intelligent Document Analyzer: An advanced machine learning solution that can
 rapidly review and extract key information from sentencing documents and court
 filings. By mining case documents and records, the tool identifies relevant factors
 such as mitigating and aggravating factors, and pertinent defendant characteristics,
 and assists legal teams in pinpointing patterns that could influence sentencing.
 This saves attorneys countless hours, while making qualitative sentencing analysis
 available to attorneys and Federal Defenders who otherwise would not have the
 resource for such endeavors.
- Interactive Sentencing Table: A dynamic, interactive version of the federal sentencing guidelines table that is enhanced with historical data and analytics. The interactive tool visualizes trends for example, how often and to what degree sentences fall below guideline ranges for certain offenses. Advanced filters allow attorneys to drill down to very similarly or identically situated sets of defendants.
- BOP Population Tracker: This application provides rated capacities for each BOP facility, and tracks BOP populations at all facilities weekly, providing attorneys and judges the ability to assess how under or over-populated a facility is at any given time.
- Life Expectancy Calculator: Often overlooked in preparing for sentencing is the
 adverse impact a custodial sentence will have on a defendant's life expectancy.
 Even seemingly short terms of imprisonment can be tantamount to life sentences
 for some defendants. This tool provides an estimate of that impact based on a peerreviewed and widely cited study and data published by the Bureau of Justice
 Statistics.
